## INSTRUCTIONS

### Cleaning and disinfection of drinking systems in empty barns

Use a 1-3% Intra Hydrocare concentration, and leave it for one night in the drinking water system. Ensure there is always air-escape in the drinking system.

### Cleaning and disinfection of operational barns

Start with a dose of 50 ml per 1,000 l of drinking water and increase this dose every two days by 50 ml to the dose of 250 ml per 1,000 of water. **In case of severe biofilm / pathogenic bacteria pollution, a water analysis is recommended and first clean the system when the animals are not present.**

The dose of 250 ml per 1,000 l of drinking water may be used as a maintenance dose.
